Nirupam & Associates, Chartered Accountants, Kolkata had on 02.09.2022 given their Expression of Interest for appointment as Statutory Auditors of the Company and accordingly, the Board of Directors of the Company at its meeting held on 06.09.2022 decided to appoint them as Statutory Auditors of the Company and the said appointment was also approved by the shareholders at the AGM of the Company held on 30.09.2022. However, M/s. Nirupam & Associates, vide their email 07.11.2022 conveyed their inability to act as Statutory Auditors of the Company due to pre-occupations. The Board has taken note of the same,
- 2. The Board was informed that M/s. Rakesh S Jain & Associates, Chartered Accountants, Hyderabad has given their consent to be appointed as Statutory Auditors of the Company and the said consent was tabled before the Board. The Board has taken note of the same and decided that the Company may appoint the said Firm as the Statutory Auditors of the Company with immediate effect and complete statutory procedural formalities related to his Appointment

3. Pursuant to the appointment of the new Auditors, the Board has decided that the Company shall submit to BSE & NSE request application seeking extension of time for submission of unaudited financial results of the Company (Standalone & Consolidated) for the quarter-ended and half-year ended 30.09.2022 owing to the request of the newly appointed Statutory Auditors namely, M/s. Rakesh S Jain & Associates, Chartered Accountants, Hyderabad.
